The Project

Part 1

A title page:

You may take creative license here. Using Photoshop or another graphics / paint program, create a title page that shows the name of your company and its main business activities. It should take up an 8 ½ x 11 inch area. It should also include your name, the date, and the title of the project.

Part 2

An opening Balance Sheet:

Create an opening **Balance Sheet** (in an electronic spreadsheet please) for your business. It must contain the following accounts. (It may also contain more, if you would like.)

Equipment
Business Vehicle
Bank Loan
Cash

Accounts Receivable: J. Seinfeld
Accounts Receivable: D. Duck
Accounts Payable: S. Morgenstern
Your_Name, Capital

You may format it as you wish, and you may choose the opening balances for each of the accounts. (Remember too, if you use formulas, it will make updating your balance sheet much easier!)

Part 3

Transactions:

Create and list ten **transactions** for your business. – Your transactions must affect each of the given accounts at least once. Be as creative as you would like, and don't be afraid to make some of your transactions affect more than just two accounts.

Part 4

Transaction Analysis Sheet:

Again, using a spreadsheet and the appropriate formulas (I insist you use formulas here.....), create a **Transaction Analysis Sheet** for the transactions in your business. Show calculations for Total Assets, Liabilities, and Equity at the bottom.

Part 5

Ending Balance Sheet:

Using the information from your Transaction Analysis, create the ending Balance Sheet for your business.
